Directives for Match Officials at World Title Competitions and ITTF Sanctioned Events

Definitions

World Title competitions include – but are not limited to – the table tennis competition at the Quadrennial Summer Olympic, World Olympic Qualifications and Youth Olympic Games, the Quadrennial Summer Paralympic Games, the World Team Championships, the World Individual Championships, the World Junior Championships, the World Para Table Tennis Individual Championships, the World Para Table Tennis Team Championships the Men's World Cup, the World Cup, the World Team Cup, and other events so designated by the Executive Committee.

World Tour event: all events according to the ITTF calendar marked as World Tour and Platinum Event, but excluding Challenge events.

ITTF Sanctioned events include all events so designated by the Executive Committee and published on the ITTF calendar from time to time.

Host - Host Organizing Committee, Host Association, Host Governing Body.

URC – The Umpires and Referees Committee; the Chair of the Umpires and Referees Committee; any of the designated officials of the Umpires and Referees Committee.

IR - ITTF International Referee.

IR(A) – ITTF International Referee Advanced – very competent referees identified by URC who have undertaken, or are undertaking, a suitable training and evaluation program. Any reference to IR also includes IR (A).

IR(C) – ITTF Certified International Referee – an individual who has passed the referee examination, but with insufficient English ability; can officiate as a referee or deputy referee in countries where their language is spoken.

NR – National Referee – individuals who have successfully completed their Association internal National Referee certification program or the ITTF certified National Referee's Course.

IU - ITTF International Umpire - also referred to as White Badge (WB).

Blue Badge IU (BB) – ITTF International Umpire who has attended an Advanced Umpire Training course, passed an Advanced Rules Exam and fulfilled all other requirements under the Blue Badge Umpires Programme.

Blue Badge in Progress IU (BBiP) – ITTF International Umpire who has attended an Advanced Umpire Training course, passed an Advanced Rules Exam but is yet to fulfil all requirements under the Blue Badge Umpires Programme.

NU – National Umpire – individuals who have successfully completed their Association's highest internal umpire certification program, or the ITTF certified National Umpire's Course.

Match officials - include referees, umpires, evaluators, course conductors, and umpires' coordinator.

Number of Referees

Number of Referees = Referee plus 2 deputy referees for one playing hall of 16 tables or less. For each additional hall or if a playing hall has more than 16 tables then an additional deputy referee is necessary. These numbers may need to be increased for World Championships, especially for qualification days where local IRs or NRs may be used. For events with 4 or fewer tables only 1 deputy referee is required. If considered warranted 4 referees could be used for one hall of less than 16 tables, especially if the event lasts 4 days or longer.

Number of Umpires

All events are divided into different stages:

Qualification, Main Draw and Final Days (last two days of an event)

Each stage requires a different number of umpires. The number of umpires depends on the tables in use for each stage.

Umpires are only present for the stage for which they are selected.

Following minimum number of umpires are necessary:

World Title Competitions:

Qualification and Main draw (with more than 2 tables): Number of tables \times 4 + 4 Main draw with 2 tables: Number of tables \times 4 Final days with 1 table: 6

World Tour Events:

Qualification: Number of tables x 2 + 2 - at least one umpire per table is required

Main draw: Number of tables x 4

Final days (1 table): 6

Other ITTF Sanctioned Events:

Qualification: Number of tables x 2 + 2 - at least one umpire per table is required

Main draw: Number of tables x 4

Nomination, Acceptance and Declination of Match Officials

All Referee and Umpire nominations must also be accepted – or declined – by the Association of the nominee. Age will not be a consideration in the selections of Referees and Umpires.

To achieve ITTF objectives, special consideration should be given to the selection of women for the positions of referee and umpire at all World, Olympic and Paralympic events.

The URC has the discretion to waive certain requirements for ITTF sanctioned junior events and the PTT Division may waive certain requirements for PTT events.

The URC, in consultation with the Competition Program, has the discretion to override any of these Directives in exceptional circumstances.
