These cancellation amounts will be added to the associations's invoice to be paid, together with the hospitality costs, to the organizers either by bank transfer or by cash on site.							
	For seeded players a fee of US\$ 2000 , unless a medical certificate is submitted, and the player does not compete in other events during the event. In case a medical certificate is submitted and approved by the ITTF the normal cancellation as for non-seeded players will apply. The ITTF will confirm to the LOC the cancellation fee to be charged in these cases. Associations will not be allowed to enter future WORLD TOUR and CHALLENGE events if any cancellation fees remain outstanding.
