   The event will be conducted in accordance with the current Laws of Table Tennis, the Regulations for International Competitions, as modified or supplemented by this prospectus.

   Updated (2/3/21)
   <u>Multi balls:</u> The multi balls system will be implemented for all matches, from the time the schedule is down to 4 tables. Prior to each match the players are free to select 15 balls each.

   11. EQUIPMENT

   12. ELIGIBILITY
   The event is open to National Associations satisfying the following conditions:
  - Their National Olympic Committee (NOC) has not yet qualified their maximum quota for the Tokyo 2020 Olympic Games Singles events.
  - Written confirmation from the respective NOC, confirming the submitted players' entries.
  - Players are eligible for participation in the Olympic Games, as per regulation 4.5.1. of the ITTF Handbook.
- **13. ONLINE ENTRY**ITTF accepts only online entries (both for preliminary and final), through the ITTF**SYSTEM**Online Entry System, under the tab "Olympic Qualification".

National Associations must use the username and password, as used for other events. For NOCs with more than one National Association special login details will be sent to the NOC, upon official request to the Competition Manager.

14. ENTRIES

## A. PRELIMINARY ENTRIES

The intention to enter and confirm a delegation will be the first **required step** on the ITTF online entry system.

The closing deadline is 23 January 2021, 23:59 GMT

Players still competing in Continental events after this date and before the 2020 World Singles Qualification Tournament must fill the preliminary entry with all information required.

For players who might qualify through one of the Continental events, cancellations will be automatic, following a confirmation of the continental quota, and without any cancellation fee.

### **B. FINAL ENTRIES**

Final entries must be submitted on the ITTF on-line entry system by providing all necessary information. The final entries system will be open from 24 January 2021.

### Final entries deadline is 5 February 2021, 23:59 GMT

The maximum number of players a NOC may enter equal to the remaining quota places available to them.

The Local Organizing Committee (LOC) guarantees that accommodation will be provided for those participants that fulfill the entries and accommodation forms on time.

No additional entry will be allowed after the final entry deadline, only changes or cancellations (modifications) are accepted in case of all accredited persons.

#### **C. MODIFICATION OF ENTRIES**

Modifications to the accepted entries, received after the final entries' deadline must be made through an e-mail to the ITTF Competition Manager and confirmed.

- **25. MATCH OFFICIALS** All matches will be officiated by qualified umpires in accordance with the Directives for Match Officials at World Title Competitions.
- 26. OBLIGATIONS The entry will contain a statement that players nominated are willing to compete against any other participating player or team and that the participants respect and acknowledge regulations and rules of the ITTF Handbook. This statement must be confirmed by a responsible official of the nominating National Association and no entry form will be accepted unless such an undertaking has been given.
- 27. LIABILITY A. By entering the event, participants agree to abide by all ITTF rules and by the rules and regulations of the LOC. All entered associations, and players agree to be under the auspices of the ITTF and its agents in all matters concerning television coverage, video, internet web casting, motion picture coverage, and photographic coverage of any kind. Participants release all rights, or rights held by their agents or sponsors, in all matters relating to television and web casting coverage, video and motion picture coverage, and photographic coverage of any kind; and hence accept such coverage during the event. A participant's refusal of above listed coverage may be subject to suspension or dismissal from the competition. Any participant, when called upon, must appear promptly to press conferences or medal presentations and follow the procedures set by the ITTF and the LOC.

B. By entering the event, each association must ensure that all delegation members confirm that they know that their personal data will be shared with the LOC and ITTF who, in turn, undertake not to share it with any unauthorized person in any way.

C. In the context of betting, participants in the event shall follow the ITTF Code of Ethics (Chapter 6 of the ITTF Handbook). They shall not, by any manner whatsoever, infringe the principle of fair play, show unsporting conduct, or attempt to influence the course or result of a competition, or any part thereof, in a manner contrary to sporting ethics. Any violation of this principle shall be disciplined according to provisions of ITTF regulation 3.5.3.

D. By entering the event, all delegation members undertake to abide by the ITTF's anti-doping rules in effect (Chapter 5 of the ITTF Handbook).

E. By entering the event, all delegation members undertake to abide by the Code of Ethics and ITTF Anti-Harassment Policy and Procedures (Chapter 6 & 7 of the ITTF Handbook).

F. By entering the event, each association must ensure that all delegation members have medical insurance for the duration of the event.
